## RECOVERY TEAM REPORTS



The Recovery Team met July 13 for our weekly meeting at the McLellan Center of Bowdoin College. We are reviewing input from the congregation every week. We bring to the Team any e-mails, personal conversations and written comments. These are recorded in our minutes so that we can revisit ideas as we move forward. Please sign anything you put in the suggestion box at a service. We do not know how to address unsigned comments and there is no way to reach you if we need clarification.

The Board approved our request to proceed with a contract with **Service Master/Elite** to act as our agents in the process of determining the final settlement from our insurance company, pending our reference checks. Dexter had completed the reference checks which were uniformly positive. He spoke to two church leaders and two large property owners who had used their services. His report indicates: "Most have used ServiceMaster/Elite based more on faith than due diligence. The recurring themes include great communications, incredible attention to detail both in working with the insurer and in the reconstruction, absolute honesty, excellent tools, broad experience managing very emotional and complex process, and thinking on behalf of the client.

The specific examples of their excellent performance ring true. They have been very appreciated by their clients who go out of their way to provide examples of their great performance. In my experience, these are hard to fake. I was impressed with their high regard for ServiceMaster/Elite." Based on that report we have finalized a contract to be signed with them for the insurance settlement process.

We received two offers to do benefit concerts on our behalf.

**Jim Scott** will be in Maine in August and wants to use his concerts as benefits for our church. He is doing all of the venue and date arranging. Once he has dates and places set we will be sure these are on the Council's events calendar so that perhaps some of us can attend the concerts.

**George Lopez**, artist in residence at Bowdoin College, has offered to do a concert for us. For those who have heard his family play in church but have not heard him, this will be a real treat. Grace is going to work on this and it will be planned for some time next spring.

Just a reminder that starting in September we will be meeting at the **Minnie Brown Center** at 906 Washington Street in Bath, owned by the Beth Israel Congregation. The space is large enough to accommodate all of us for a single service each Sunday with RE space, bathrooms and kitchen down stairs. Directions and maps will be available long before our first service there.

## RECOVERY TEAM REPORTS

Your Recovery Team continues to meet weekly. We are very appreciative of the involvement of so many members of the Congregation in the meeting on Sunday and of the outcome of that meeting. The dreams and memories everyone wrote during the service are amazing! We will make sure they are available for you to read, but are mindful of not killing too many trees, as we have seven or eight pages of ideas. I am happy to send an electronic copy to anyone who wishes.



With a portion of the money approved on Sunday we are engaging the architectural firm of Smith, Reuter and Lull to work with our Team and the Congregation to develop concepts and ultimately a plan for building new or rebuilding a worship space for our congregation. There will be many opportunities for input from everyone as we go through this process. As a first step they will give us a timeline so that we can be aware of how much time each part of the process may take. We suggested that we would like to be in our new worship space at the latest by our bicentennial in September 2012. This seems a long way off, but the time to build or rebuild wisely will be well spent.

We plan to have a congregational discussion in August to begin the process of deciding where we will be and what we envision for our space. This meeting will be facilitated and we hope will give us all some guidance as we continue this part of our recovery. As soon as a date is set everyone will be notified.

We have continued to work with the Beth Israel Congregation about using the Minnie Brown Center beginning in September. At a recent meeting with some of their leaders the question of how we might help them came

up (since they were not asking for a set fee for use of the building). A number of possibilities were raised around improvements they would love to see in their building. They were not asking that we do these things but were just saying what they would do if they could. The Recovery Team and the Board decided that what we should do is pay them a fair rent for the space. They have said we can use the Center any time they are not. This allows us to use it for pot luck suppers, meetings, etc. as we need. We looked at the amount we would have to pay if we used a school in Brunswick or Topsham (about \$100 a Sunday and little or no opportunity for use other than Sunday mornings) or if we used the Adventist Church (about \$250 a Sunday). We decided that \$500 a month would be fair, and we will propose that to the Beth Israel Board. That way if they want to make improvements they can, and we will feel we can use the space while covering their utility costs and “wear and tear” from our use. This is covered by our insurance and we have reviewed this carefully with the agent from Church Mutual several times.

## A YEAR TO REMEMBER

The UUCB Strategic Plan 2009-2014 has taken a detour because of the tragic fire in our church building. But we can't let the fire deter us from recognizing, gratefully, that several major Strategic Plan objectives moved forward this past year, notably a church-wide *social justice program*, an *adult religious education program*, and *Green Sanctuary certification*.

The process of selecting a social justice focus was a very democratic one, and correspondingly lengthy. It required considerable thought and considerable time on the part of many congregants, and it's very much to the credit of the congregation that both were generously given. The final outcome was the formation of a Working for Justice Steering Committee that concentrates on efforts to reduce expressions of prejudice and hate. A workshop with guest leader Peggy Smith of the Maine Nonviolent Communication Network was held in April, and an affecting and informative film, "Bullied", was shown still more recently. As part of this year's UUA program, many people read the book "The Death of Josseline", dealing with the often deadly journeys undertaken by illegal immigrants on the Arizona/Mexico border and the efforts of border dwellers to either help or hinder them. Next year will see more initiatives on this front.

Volunteers who have expressed a strong interest in adult education have begun to move on this initiative as well. Two volunteers (Pat Harris and Hank Simpson) will consider what sort of courses we might offer, avoiding duplication of topics or skills already made available by other institutions, and how to make our offerings relevant to Unitarian Universalists in particular. Planning for the future continues, but meanwhile Sylvia took advantage of materials newly available through the UUA to offer an 11-week course on UU theology, *What Moves Us*. Eight or so congregants took part in two-hour sessions, making the acquaintance of UU theologians representing several centuries. In addition, Sienna Dode and Pat Harris offered a Soul Searching class enjoyed by other congregants.

Our application to the UUA to become a certified Green Sanctuary has been submitted, capping the multi-year efforts of a very dedicated and hard-working Green Sanctuary Committee. The application

included a congregational statement of commitment to environmental sustainability and a socially just human presence on the planet. The statement was unanimously approved at the Annual Meeting.

Many specific objectives of our five-year strategic plan (see the UUCB website > Committees > Strategic Planning Committee > Strategic Plan) are stymied by the results of the fire, but many others, especially those directed to being a spiritual community, nurturing one another, and welcoming all, are still very much in effect and in some instances even enhanced. The *open Chalice Circle sessions* are one example: those devoted in July to memories of congregational life in our UUCB church home, and those scheduled for this month, devoted to our hopes and dreams for renewed and reaffirmed congregational life. Offering *summer-season fellowship dinners or lunches* is another example – an unusual one for a congregation that until fairly recently took a two-month break from church activities during the summer. Providing a *full summer program of worship services* with regular *after-the-service hospitality* is yet another example of enriched fellowship possibilities despite our displacement to an unconventional location.

If any indication were needed of our congregation's whole-hearted response to the new post-fire circumstances, the turn-out for the congregational meeting on June 17<sup>th</sup> -- a beautiful summer Sunday morning that suggested many, many alternative activities -- provided it: about 100 members stuck it out in a room growing warmer by the minute to join in a good discussion and an important vote. Bravo, all!

## FUNDRAISERS

### HANNAFORD CARDS

Sue Michaud will be selling Hannaford Cards at most of the summer services. Please look for her near the exit of the Morrell Room. If you haven't bought any cards from her, it is a very easy way to donate money to the church without spending a dime of your own money. You simply buy the gift card in the amount that you wish to use at Hannaford, and then go grocery shopping at ANY Hannaford—no expiration date.

- ♦ If your purchase comes to more than the card, you simply pay the rest with your check or ATM card.
- ♦ If your purchase is less than the amount on the card, the remaining balance is recorded on your card for the next time you go shopping.

Last year, the Hannaford cards earned almost \$4,000 for the church. If more start using them, we could double that amount.

### WOOD REPLICAS OF THE CHURCH

The Women's Alliance has a few dozen leftover wood carvings of our former church building that will be on sale after services as well. These wooden keepsakes were created by "The Cat's Meow." and sold at our craft fair.

### August Charity


In August, our collection plate is shared with *Keep ME Warm*.

Our summer hasn't been much of a time to rest. This is only a partial list of recent accomplishments (with sincere thanks to the *\*stars*).

- ♦ Plans are settled for our new, regular meeting place in Bath starting September 11. (*\*Heidi Neufeld and the Recovery Team; and \*the Beth Israel Congregation* for their warmth and generosity in welcoming us into the Minnie Brown Center)
- ♦ The *\*Church Administrator Search Committee* worked quickly to settle on an outstanding candidate. The announcement should be released very soon.
- ♦ The new Pennell House natural gas heating system is nearly complete. (*\*Erik Hansen and the Properties Committee*)

- ♦ Nearly 100 *\*members and friends* attended the Congregational Meeting on July 17 following the *\*Recovery Team's* engaging service.

With the congregation vote to engage the architect and the hard work of the Recovery Team, we are making steady progress. The current stage should lead us through critical decision points to get a plan in place later in the fall. I know you've been listening-and thinking. The dreams and

## DIRECTIONS TO THE MINNIE BROWN CENTER

### 906 Washington Street, Bath, Maine

The building we will be using is next door to the sanctuary used by the Beth Israel Congregation. It was purchased in 2002 and houses their Hebrew school. On the main floor there is a Rabbi's study and a large function room that can be used for our services. Downstairs are six small classrooms, a kitchen and an eating area.

#### From the North

- ♦ As you travel across the Sagadahoc Bridge from Woolwich into Bath look for the sign "to 209 / Bath Phippsburg / right lane / exit only." Stay in the right lane. There will be a stop sign at the beginning of the exit.
- ♦ Continue straight onto Vine Street and travel 1/10 mile. Bear right just before the traffic lights.
- ♦ Turn right onto Washington Street. Travel 3/10 mile. (You will be passing one set of traffic lights and the Chocolate Church Arts Center on your left.)

#### From the South

- ♦ As you enter Bath along Rt.1 look for the sign "Bath Right Lane." As you move to the right lane, look for the sign "Historic Bath." Travel down the exit for 3/10 mile until you reach Washington Street at the traffic lights.
- ♦ Turn left at the traffic lights onto Washington Street. Travel 3/10. (You will be passing one set of traffic lights and the Chocolate Church Arts Center on your left.)
- ♦ The Minnie Brown Center is a white and red brick building on your left. There is parking behind the building as well as on the street.
