## ... MINISTER'S MUSINGS...



And again.

These are hardworking, hectic times of change for our congregation. We will need to keep breathing deeply to stay connected to our energy and strength.

In some ways, we are not unlike our forebears who 200 years ago created a Universalist church in Brunswick on January 20, 1812. They were embarking on a whole new journey together – one that is still ongoing. We, who

follow in their footsteps, now take the next branch in the trail of that journey.

Before our church burned, I had been planning to spend the summer studying more of our history in anticipation of a gala bicentennial celebration that would have been carried out over many months. So much for making plans!

While our amazing birthday hasn't been forgotten (and indeed the Bicentennial Task Force is still working on plans), the immediate needs of the church changed in the wake of the fire. Now I think one of the best ways we can honor our history is to vow to carry it forward, leaving our church strong, vibrant, and healthy for those who will follow after us. That's what we're doing now.

With the New Year, we turn our eyes forward to rebuilding. A new Building Team now begins to work in earnest to create plans with the architects. A Capital Campaign Committee now partners with a consultant to help us establish the healthiest financial foothold our combined forces can create. What wonderful things to contemplate! We have energetic, creative, and wise people guiding us through this period. Out of our misfortune, amazing things have emerged. I think our forebears would be proud if they could see how resolute, committed, and energized we are in the face of adversity.

On December 20, our old building came down. I think of a building as strong and stable. Seeing ours quickly destroyed and the rubble hauled away was almost more than I could take in. The sounds, smells, and sights of that day provided a harsh, palpable closure for me. For many weeks now, I have known the building was about to come down. Having to wait and wait and wait felt like pulling a band-aid off one hair at a time – painful! I am grateful now for the closure, even as I recognize my swirl of emotions mixed in with it.

As the heavy machinery rolled over our past, I imagined myself back in that space, remembering how it felt to walk through the sanctuary, how the acoustics in the room made us sound like the Mormon Tabernacle Choir. I remembered the smell of the church, both before the fire and

after. I recounted countless meetings around the big table in the Community Room, and I envisioned kids swinging around on the poles.

The memories comforted me. So too did the knowledge that we are creating new memories while we are homeless, and creating more new memories is in store for us someday in our new sanctuary. For me, all of it is my church – the history, the memories, the present, and the dreams for the future.

We have much to grieve, much to anticipate, and much to be grateful for as the New Year greets us. We have journeyed far, and we still have far to go. May we remember that 200 years ago, our forebears embarked on a journey when they formed a new church, a Universalist church, in Brunswick. They couldn't know the outcome of their decisions then any more than we can know the outcome of our decisions now. They looked ahead and chose as best they could, guided by faith that their decisions were good and true. May we carry forward their legacy of bold dreams and actions and their confidence that our faith is a worthy guide to us now and a beautiful legacy to leave to those who follow us.



## **WORKING FOR JUSTICE:** Looking Beyond Ourselves...

Our church is hosting a community-wide discussion on January 31, inviting people of other faiths, ages and cultures to discuss and reflect on the reality of prejudice and hate in our community and in the state of Maine. Working with others we hope to envision and create opportunities to turn our UUCB principles into action.

Last spring our church learned of a series of incidents in Brunswick in which people of color felt threatened and unsafe. In response, Working for Justice organized for our congregation a spring workshop with nonviolent communications trainer, Peggy Smith, and, this November invited Steve Wessler, civil rights advocate and educator to speak at the November 13 Sunday worship service.

With Steve's guidance we have connected with Bowdoin College, local clergy, high schools and business people - receiving their interest, concern and enthusiastic support. We hope this community gathering will be the beginning of a commitment by UUCB to work with others in the community to assure that all people who work, study and live in Brunswick feel welcomed and safe.

On **Tuesday, January 31 from 5-7pm in the Curtis Library Morrell Room** Steve Wessler will give a presentation and oversee small group discussions co-facilitated by Bowdoin College students and community members. The organized discussions will be followed by a potluck and further informal conversation.

## **CAPITAL CAMPAIGN/ANNUAL BUDGET DRIVE**

We've been working throughout December, and we are pleased to report that after interviewing and considering two strong candidates, we have chosen Rev. Peter Heinrichs as our UUCB fund-raising consultant for the combined Capital Campaign and Annual Budget Drive. Peter has a long history with both UU and UCC churches. References describe him as being a "gifted listener," "a superior coach at all levels," and "great at maintaining energy in those he works with." More background about Rev. Heinrichs, below.\*

Peter lives and works nearby, so he can be flexible regarding the hours he spends with us. He'll conduct our Feasibility Study - probably in late January - and in the meantime he'll meet with the Campaign and Annual Budget Drive committees, the Building Team, church leadership, and others. The Board approved payment of Peter's initial fees so that we can get started. Given that the full consultation costs will be more than \$5000 and thus require a vote, the Board anticipates seeking congregational approval in January, probably in conjunction with a vote on other costs and fees.

We expect that congregants still have questions about the timing of decision-making, construction, and fundraising - we certainly do! Our Publications group of Rich Knox, Nancy Dorian, and Larry Lemmel will soon post an easy-to-read TIMELINE about UUCB

Recovery, Construction, and Campaign at the rear of the sanctuary each Sunday, and online, too. At the display, Campaign and Building Team folks will answer questions and help orient everyone as we progress through the year. We're also happy to speak with anyone individually iust email or call.



In the 1980's Peter served as minister for two UU congregations, then worked as Director of Development for the UUA, assisting congregations around the country in their fundraising efforts. Later, he spent 22+ years as Senior Minister for a large UCC church in Springfield, MA. While there, he led the congregation's successful capital campaigns and

## LEAVE-TAKING CEREMONY

**December 3, 2011** 

Out of wood and brick, out of imagination and sacrifice, out of the ashes of their burned meeting house, our forebears built this church home. With the work of their hands, the commitment and courage of their bearts, and the creativity of their minds, our forebears crafted a sacred space where free religious thought prevailed and love guided the generations.

This bouse of worship has given us a center where hearts could meet: meeting one another over lifetimes and across the generations; meeting one another in warmth and joy and openness; meeting one another in times of joy and sorrow; meeting one another in times of success and failure; meeting one another in courage and love; meeting one another in thick times and thin; meeting one another in times of war and peace.

This house has been cradle to our growing and our loving. This building has been a center of trust and passion, of love and laughter, of misunderstanding leading to reconciliation and forgiveness, a place of soaring song and quiet contemplation. These walls have known the silence of the generations of bearts who have come here to search inward for the small sparks of hope that might otherwise have been snuffed out in the noise of the world. These rafters have beard the voices of children, preachers, and singers, and witnessed tears and smiles of all. On these floors have trod the footsteps of dancers and musicians, sextons and committee members, visitors and long-time parishioners, and young and old across seven or more generations.

Today we gather to bless this house, to express our gratitude for its physical, emotional, and spiritual shelter, and to bid goodbye. We say goodbye knowing we follow the example of courage and determination of our forebears who built their jewel of a meeting bouse bere on this corner after their own church had burned. We say goodbye knowing we follow in their footsteps, confident that we will rebuild a meeting bouse bere worthy of the sacrifices they made.

We say goodbye, grieving for what has been lost and vowing to hold memories and dreams in our hearts until the day we return. We say goodbye, with gratitude that our lives have been touched here, our minds have been opened and filled here, and our hearts have been nurtured and filled here.

For those things and for so much more, we offer a deep bow of thanks and a vow to return again.

## **A BICENTENNIAL MOMENT**

On January 20, 1812, 31 Brunswick men signed the first covenant of a new church legally incorporated as The First Universal Christian Society. 2012 being our bicentennial year, I will write a monthly historical piece telling some stories of our church.

The second Universalist church building in Brunswick, located on the corner of Mason and Maine Streets, was dedicated in December of 1846. Within its graceful landmark spire hung a bell. Col. Andrew Dennison was instrumental in raising the funds to purchase it, but he was dissatisfied with the impurity of tone of the bell that was delivered and returned it. The second bell was considered to be perfect and the story goes that Col Dennison, who directed the church choir, forgetting his tuning fork upon occasion, used the tone of the bell for the pitch he needed. The bell was rung by a man hired by the town three times a day at 7 AM, noon and 9 PM.

The Mason Street Church was destroyed by fire in

1884 and is a story for another month. The bell was badly broken when the steeple toppled, and when the metal was dug out of the ruins, it was sent to a foundry to be recast. The resulting bell was 200 pounds smaller than the original 750 pounds. The elder Col. Dennison insisted that no new metal be added lest the purity of its tone be lost.

When the bell was installed in the new church on the corner of Pleasant and Middle Streets in 1885, and was rung for the first time, it was reported that business men on lower Maine Street were heard to say, "Why, there's the old Universalist bell a-ringin'."

The bell was removed on Tuesday, December 20, 2011, 126 years later, just before the church building was completely razed. On it is inscribed: "Ring joy and peace for the world."

#### **CHURCH BELL INSCRIPTIONS**

On December 20, when our building was taken down, the moment of highest drama occurred when the bell was finally lowered from the steeple. The bell sounded a few gentle chimes as it swung from the lip of the excavator. People clicked furiously away on their cameras as the bell descended from the sky. Once the bell was on the ground, the crowd gathered around it to touch it and to view the inscriptions, which read:

"Cast by William Blake & Co formerly H. N. Hooper & Co. Boston Mass A.D. 1885

> "Cast A. D. 1847 for Universalist Church Brunswick. Andrew Dennison. Committee Broken by Fire A. D. 1884 Recast A. D. 1885 by order of Andrew Dennisons. Children

"Ring Joy and Peace to the World"

The history is interesting. The punctuation is odd. (As humorist Dave Barry would say, "I am *not* making this up!") In the midst of an emotionally wrenching day, the retrieval of the church bell provided an incredible lift. – *Sylvia Stocker* 

#### UUCB BUILDING TEAM REPORT 21 December 2011

#### THE END

It will come as no news that our over 100 year old building has been reduced to rubble and the corner of Pleasant and Middle Streets will never look the same. Many members stopped by to watch and the local news coverage was extensive. The demolition workers were skilled, careful, and generally successful. The bell was removed with little damage, the steeple came down with a crash but the weathervane survived with only minor damage, and the rubble has been crushed, removed, and will be recycled as much as possible. The long sought time capsule from 1982 was miraculously found in the rubble and it has vet to be opened. The success of the demolition seems to be a good omen for our future.

We have a complete list of all the items which were removed from the building and anticipate allowing Service Master in Saco to put the few pieces we do not wish to keep on ebay and give us the proceeds. Please feel free to email us any questions about particular items. The old stained glass is being evaluated by "experts" which will give us more information to use in determining whether or not to use them in our new building.

#### THE FUTURE

The charge to the building team has been written and approved by the board and will be posted on the Building Team website. We also discussed and agreed upon a Covenant which will also be on the site. Much time and thought has been devoted to when and how much to communicate to the congregation as a whole. We look foreword to sharing these plans when they are more fully developed. Our team will be spending many hours and the architects will be spending many days working on a design which fulfills many of our varied hopes so members of the congregation can feel secure that their opinions and input have been fully considered.

The architects did present a very rough and unfinished model of how they have been thinking about the sanctuary and it was greeted with a range of responses from great enthusiasm to relief. I believe that the size, shape, and general appearance is a very well thought out combination of the many thoughts expressed by the congregation over the last 7 months. It is likely that there will be a tower (some do not wish to think of it as a steeple) on the same corner as the old steeple and the height of the building will be similar to our old building. It will be appropriate to our location and to our public presence. We are not likely to present many more details until the plans are more complete.

We feel optimistic about our team, our architects, our congregation and our future. Have faith and patience and a peaceful and restful holiday.



#### Happy New Year



## Eat your vegetables!

(Thoughts for study and further reflection...)



With the questions below, we are each asked to revisit our connection to UUCB and to reconsider our <u>expectations</u> of each other as people who belong to and care about the UUCB spiritual community.

- 1. Reflect on a time when you gave to the UUCB community (time, treasure, and/or talent) and experienced being given to in return.
- 2. In what ways does your association with the UUCB community touch (change, impact) your life you, your family, your work, your thinking, your visions, etc.? For instance, this community ....empowers me to act on my conscience; provides a network of support over time; offers time for reflection & meditation; includes my children in a community we share, etc.
- 3. What distinguishes a spiritual community of scarcity from a spiritual community of abundance/ generosity (the spiritual community of our dream; fantasy; vision)? Consider behaviors, attitudes, images and how time, treasure and talent are involved.
- 4. What must each of us do to create a culture of abundance, a spiritual community of generosity at UUCB? (What should we expect or ask of each other?)
- 5. Make for yourself a prioritized list of the causes and concerns (including UUCB) to which you contribute your time and energy. Make a <u>second</u> prioritized list of causes and concerns (also including UUCB) to which you give financially. Does the order of your lists reflect the importance of these causes and con-

cerns in your life?



Reflect on these questions (yes, they're good for you, just like your veggies!); share your thoughts and experiences with others. Speak with Cathey Cyrus or Rebecca Darr if you would like to join others in a small group discussion

## FROM THE BOARD CHAIR...

ur congregation has certainly passed a milestone on the road to rebuilding from the fire. Watching the heavy machinery smash through the charred frame, and seeing the building's guts ripped out and wires dangling from the teeth of the backhoe, I had to keep my focus on the heart of our church. Our heart is "us". Sylvia was eloquent during the "bell ceremony" on the old church steps, and her words spoke to us all of the past and the opportunities for the future. She speaks to and for our heart.

The Wayside Pulpit now presides over an empty lot. Its message tells the community we are rebuilding, though it doesn't look like much, yet. One of the Board's most important responsibilities in the past month has been in guiding the transition from the Recovery Team to the new Building Team. We can't say enough good things about the effectiveness of the Recovery Team's work. We owe the team our continued thanks for bringing us through the very difficult reorganization and planning stages after the fire. They set a high standard for the Building Team to match in their openness, deliberation, timeliness and efficiency.

At the December Board meeting, we approved the charge to the Building Team with a long list of responsibilities and cautions. The full charge is posted on the Building Team's pages on the website and copies are available in the church office. The essence of the charge as stated in the Purpose is:

"... the Building Team, acting as an agent of the Board, is to provide overall direction and support for the processes and activities necessary to complete the building project for (1) a new church building on Pleasant Street, and (2) the possible rebuilding of Pennell House. This work includes responsibility for planning, budgeting, design, timeline and implementation through to occupation of the new space.

The ultimate responsibility for entering into contracts and making financial obligations resides in the Board of Trustees and the Congregation. However, the Building Team is charged with conducting due diligence in negotiating contracts, working with contractors making timely decisions, and managing project finances while keeping the Board and Congregation informed of activities and progress on a regular basis."

The first bullet in the charge specifies that the Building

Team will "work with the Architect in the design process to provide direction consistent with input form the Congregation and the church's financial resources." The full text of the charge lists responsibilities and focus areas for Decision Making, Operational Oversight, Financial Oversight and Communications. As your Board acting on behalf of the Congregation, we have entrusted the Building Committee to sort out many of the details and make basic decisions so that the congregation can reasonably weigh in on the major decisions rather than slog through the weeds and act as a "committee of the whole".

I know I'm not alone in looking forward to the discussions at gatherings with the architects and Congregation as we look over the ideas taking shape. But in the meantime, we should all continue to get ideas and thoughts to the Building Team by email or in face-to-face discussions with Team members. The Board is placing trust in the Building Team, along with the architects, to pare down and focus discussion before we get to large group meetings. The planning is fluid for now, but soon pieces of the plan will become firmer and lead to more and more definition. I urge patience, and for all of us to remember that the only ones who will get the church of their dreams are us, the Congregation.

In other business in December, the Board approved the hiring of Peter Heinrichs as the Capital Campaign consultant. We are enthusiastic about these "developments". Much more information will be coming out soon to spread enthusiasm for the many possibilities in fundraising. The Board also approved the hire of our new Sexton, Tony Sulkoski, who will begin work on January 8<sup>th</sup>. We look forward to having Tony take some of the load off the faithful volunteers who have filled in at Minnie Brown on Sundays. The Board also appreciates all the committees as they continue to work on behalf of the Congregation.

As many have said, the church coming down reminds us of what we've lost, and yet we move ahead with a real sense of purpose. Our heart is the "us" of the church. Our church is doing good work, and so many are working hard to continue our service to the community in support of our mission. This is a vibrant and growing Congregation of which we can all be proud. I congratulate and thank everyone for their contribution to this vital effort!
