## **Our Minister's Message**


We are all longing to go home to some place we have never been – a place, half-remembered, and half-envisioned we can only catch glimpses of from time to time. Community.

born without grandparents being able to be present, without naming ceremonies, dedications, and baptisms held in community. One year ago, I couldn't have imagined (thank goodness) that we would still be in this frozen time of waiting.

And yet March is the month when spring arrives. The time of little green shoots somehow pushing their way through frozen ground and snow — a sign of hope, a reminder of life "longing for itself." And just as in New England, March doesn't always really bring a complete thaw, we may have a ways to go yet in this frozen time of waiting. But let us have faith, Beloveds, that spring always comes. The light does return, and help is on the way. Many of you have already received or will soon receive your COVID vaccinations. The rest of us will get ours over the next few months, and gradually ... life will return to something more normal. Let us continue to be cautious, finding safe ways to "gather." And let us remember that the longing we feel now reminds us of how precious this community is. Again, from Starhawk:



#### Settled Minister Search Team

The process of forming our Settled Minister Search Team is well underway. All members have been contacted by phone, and 128 individual names were suggested. The Board has been given the top 15 names, and will proceed eventually to recommend 7 people to serve on the Team. The congregation will be given an opportunity to vote as we narrow down the list, and when we have a final slate. We anticipate installing the Team at a worship service in April. Then they get to work!

Special Congregational Meeting

Thanks to all who attended our Special Congregational Meeting on January 31st. Our Zoom screens were full! It was a great opportunity to take stock of where we are and to hear about plans for the future. It was heartening to know that, although many activities are somewhat

curtailed due to the pandemic, important things are happening, and we are in good shape financially.

Our contract with Justine stipulates that if we wish to extend the agreement for a second year, the Board should notify the Interim Minister by March 1. It was not a difficult decision. The Board was unanimous in recommending that we do so, and Justine was pleased to accept. We are very fortunate to have her helping us through the transition period.

Anita Ruff, one of our UUCB members, is working with Mid Coast Hospital to identify adults over 70 who would like to receive the COVID vaccine.

If you or someone you know is over 70 and have not received a vaccination, please email Anita at <a href="mailto:aruff@oasisfreeclinics.org">aruff@oasisfreeclinics.org</a>. Please include name, email, phone, town and age. Currently, Mid Coast is only vaccinating those over 70, so please only respond if you are over 70.

We understand that not everyone has an email; it can belong to a family member or trusted friend. By including an email, the person will be contacted for an appoint-

ment more quickly than by telephone.

Within a few days, you will receive an invitation to sign up for a vaccine, as well as the required consent and registration forms.

Again, please respond to Anita Ruff at aruff@oasisfreeclinics.org. She is the person who is coordinating this outreach. You can cut and paste Anita's email address into a blank email, then include the information she needs - name, email, phone, town and age.

#### INSPIRATION AND REMBERANCE

The following is an excerpt from the sermon by Maryli Tiemann on Feb. 21:

Recently I had the opportunity to assist in the closing of the family home of our Minister Emeritus, Brad Mitchell, after his death.

There were many days of packing and going through cupboards and files. One afternoon I came upon a folder labeled, LAST THINGS. In it were just three examples of a column Brad used to write for our Parish Messenger when he was minister.

I'm honored to share his thoughts with you from over 20 years ago.

#### LAST THINGS by Brad Mitchell

We lose a lot of life waiting for the weather to change. If you are like me, you let a drizzly day postpone the walk you were going to take. You say to yourself, "I'll just wait until the clouds go and the sun comes out." Perhaps the reason for the delay is that we think the day ahead might make us uncomfortable: the cold rain on our faces, our clothing damp, the wind-chill cutting through our serenity.

Emotional weather is like that, too. The storm clouds of anxiety or blues or impatience drive us from the moment as we put our lives on hold. "This is not the kind of life I'm prepared to live this moment," we think as we dive into one addiction or another to comfort ourselves until the weather changes.

Yet, the necessary fact of life is that weather changes are integral to living. My sense of it is while temperate and sunshiny days offer us the chance to celebrate life, stormy weather offers us the opportunity to deepen our lives. We need both the celebration and the deepening; both enhance our life experience. In stormy weather we have the opportunity to seek out that which really sustains us and to find the beauty and truth in our lives that is not so overt and obvious. The blues may haunt us, but they offer us the opportunity to plumb the depths of our being and to face truths we may be ignoring.

Yes, we need the sunshine for celebration, but let us not postpone living in the storms. Let us live the storms with a different kind of energy, which moves inward and reveals to us our deeper selves.



### **Immigrant Justice: Legal Fund**





The Emergency Action Network (TEAN) and Mid Coast New Mainers Group (MCNMG) continue their major fundraising effort to raise \$100,000 to aid new Mainers in Midcoast Maine with the legal expenses anticipated in their efforts to achieve asylum seeker status. \$60,000 has been raised to date with the help of many in the UUCB and wider community who were able to contribute. The asylum seeker families are eager to contribute to their own legal expenses and have contracted with the lawyers to do so, but most are still waiting to receive work permits - delayed repeatedly by federal policy changes and an overwhelmed immigration system.

It is estimated that each asylum court case will cost about \$6600 not including application fees, translation and mailings. There are 23 Brunswick/Bath families, some of whom will have more than one court case due to the complicating circumstances of their particular situations. TEAN will be the holder of the funds in an account designated for this purpose.

#### **Indigenous Awareness**

With the convening of the 2021 Maine legislative session, the newly reconstituted Judiciary Committee has begun to educate itself about the issues involved in last session's bill, LD 2094 – An Act to Implement the Recommendations of the Task Force on Changes to the Maine Indian Claims Settlement Implementing Act.

Discussion and action on Task Force recommendations stopped in February, 2020 with the arrival of COVID – 19 and the subsequent closing of the legislative session. Citizen advocacy will help to assure that those recommendations get full attention by the new Judiciary Committee. Successor bills for last session's LD 2094 are now being considered. (LR 1341; 196;1551, 1787 and 1337). MUUSAN's issue group on Racial, Native, and Immigrant Justice is organizing support for these successor bills.

Tedford Housing's mission is to empower people to move from homelessness to home.

Our programs include two emergency shelters, supportive housing units, and homeless prevention and outreach services. We serve individuals and families in every facet of our work, in order to best serve those experiencing homelessness and those on the brink of homelessness.

We serve 10 people in our emergency adult shelter, and 6 families in our emergency family shelter. Tedford has 37 supportive housing apartment units in Bath, Brunswick, Augusta, Lewiston, and Auburn. We have a growing homeless prevention and outreach program to reach those on the brink of homelessness and those that we cannot yet serve in the community. In fiscal year 2020, Tedford's programs served a total of 715 people in Maine.

### **MUUSAN Update:**

## Racial, Native and Immigrant Justice & Legislative Priorities

UUCB is playing a bigger role in MUUSAN—The Maine Unitarian Universalist State Advocacy Network.

The MUUSAN networking relationship enables the UU congregations in Maine to work collaboratively in ways that increase our collective social justice work at the State legislative level. As MUUSAN delegates, we identify priority issues and then focus on particular bills that support those priorities as well as those that do not.

I am participating in the Racial, Native and Immigrant Justice Issue Group which addresses systemic oppression by advocating with and on behalf of racial, ethnic and indigenous populations and responding to the need to interrupt disparities in Maine's legal and economic systems. We are currently working on prioritizing legislation under this focus area.

I am also the Congregational Legislative Liaison between UUCB and the MUUSAN network. MUUSAN's website has links to two helpful resources about pending legislation — the MUUSAN Legislative Agenda and the Advocacy Calendar.

The Legislative Agenda shows the bills now in process, grouped by MUUSAN's priorities. Note that LR-numbered



bills have been entered and are in the process of going forward. LD-numbered bills, highlighted in blue, are published and now being considered and acted upon. The Advocacy Calendar shows the bills pending and their advocates including MUUSAN.

My role as the Congregational Legislative Liaison is to inform UUCB members of action alerts and other advocacy opportunities. One bill, LD2, focuses on systemic oppression by advocating on behalf of racial, ethnic and indigenous populations and the need to interrupt disparities in Maine's legal and economic systems. Supported by MUUSAN, LD2 requires the inclusion of racial impact statements in the legislative process. Such impact statements are viewed as an essential step in identifying the disparities of systemic racism in practice.

In an upcoming Parish Messenger, I will notify you about how to sign up for timely alerts and reports on bills that are of particular interest to you.
